WHEREAS, Mr. Riddick currently serves as president of Riddick Funeral Services, and is a long-standing faithful member of Grace Episcopal Church; and

WHEREAS, Mr. Riddick was recognized as a Citizen of the Year by Lambda Omega Chapter of Omega Psi Phi Fraternity and was honored as a Citizen of Tomorrow by Zeta Phi Beta Sorority.
